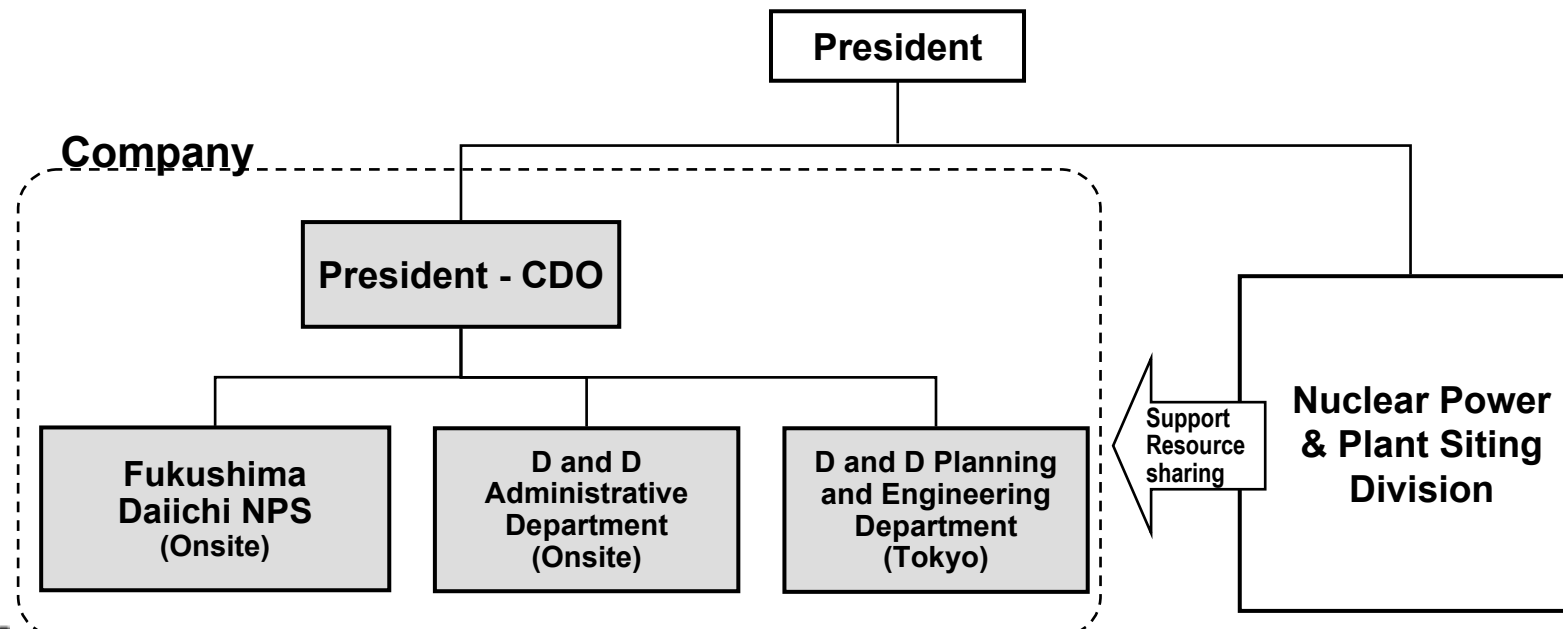


# Outline of the Establishment of Decommissioning Company (provisional name)

## Organizational outline of Decommissioning Company\* \* Its official name is still under consideration.

- The Company will have Chief Decommissioning Officer (CDO) as a chief administrator, and will be comprised of Decontamination and Decommissioning (D and D) Administrative Department\*, D and D Planning and Engineering Department\*, and Fukushima Daiichi Nuclear Power Station.
  - D and D Administrative Department: Controls the entire Company, and builds up foundations for supports and operations.
  - D and D Planning and Engineering Department: Formulates policies and plans for solving problems involved in decommissioning and contaminated water management.
  - Fukushima Daiichi NPS: Finds solutions to problems involved in decommissioning and contaminated water management and implements the solutions.

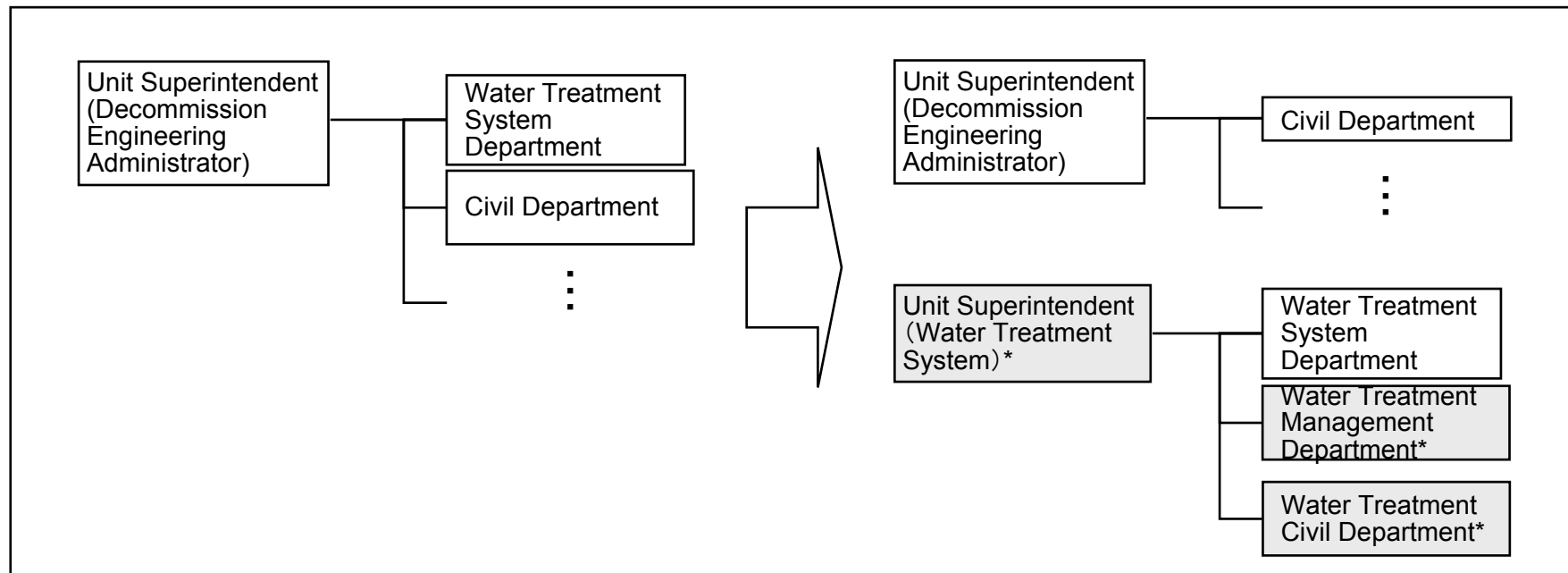


# Organizations and Responsibilities (1)

- Responsibilities of D and D Administrative Department and D and D Planning and Engineering Department
  - ✓ Main activities to be conducted by D and D Administrative Department
    - Controlling activities such as Company's operational planning and management review
    - Activities related to operational infrastructure such as human resource administration and development, and budget management
    - Quality and safety activitiesetc.
  - ✓ Main activities for D and D Planning and Engineering Department
    - Formulation of policies and plans for decommissioning and contaminated water management
    - Technical review of facilities for decommissioning and contaminated water managementetc.
- ⇒ Following descriptions of responsibilities of the D and D Administrative Department and D and D Planning and Engineering Department has been fixed.
  - ✓ **D and D Administrative Department assists the chief administrator, and conducts activities for controlling safety and quality, and planning, managing and training human resources, in the decommissioning implementation unit.**
  - ✓ **D and D Planning and Engineering Department conducts: activities for formulating plans of mid- to long-term measures for Fukushima Daiichi NPS, and conducting overall management and technological review; and activities for formulating and revising the implementation plan.**

# Organizations and Responsibilities (2)

- Reorganization relating to the water treatment unit  
Intensification of the management through creation of a Unit Superintendent in charge of the Water Treatment System, Water Treatment Management Department, and Water Treatment Civil Department

# Organizations and Responsibilities (3)

## ➤ Chief administrator

- Chief Decommissioning Officer (CDO) is to perform the following tasks, which have been performed by General Manager of Nuclear Power & Plant Siting Division.
    - Enforcing compliance with relevant regulations and the technical specifications, and fostering a safety culture
    - Assuring quality
    - Committee on the safety of Fukushima Daiichi Decommissioning
    - Appointment of licensed engineers of reactor
- etc.

## ➤ Reorganization of the Fukushima Daiichi Stabilization Center following the closedown of the Center

- Following the closedown of Fukushima Daiichi Stabilization Center, the functions of Fukushima Daiichi Stabilization Center are to be transferred to Decontamination and Decommissioning Administrative Department and General Affairs Division at the site.

## ➤ Establishment of manuals

- In order to responsibly advance the decommissioning work, the Company will be independently in charge of manuals.
